Terms & Conditions

- 1. Subject to the "xBar Cup 2025" Terms and Conditions (the "Terms") and easyMarkets¹ business terms and policies, participants that meet the criteria of the Terms set forth hereinafter will be eligible for the "xBar Cup 2025" promotion as defined below.
- 2. The promotion will commence on 04 October 2024 and will end on 15 May 2025 (the "Promotion Period").
- 3. Subject to, and without prejudice to, all other Business Terms and Policies, this promotion is available to participants ² who have satisfied the Eligibility Criteria ("Eligible Participants") as set out in the sections following hereinafter.

The Eligibility Criteria are as follows:

- a. This promotion shall apply to participants through this Link.
- b. Only persons who can form legally binding contracts under the laws applicable in their country of residence may participate; without limiting the foregoing, participation in the promotion is not allowed for persons under the age of 18.
- c. - post at least (1) one participation video on their social media accounts
- repost the participation poster of our accounts
- post at least (3) three stories (reminders/ send traffic voting) on their social media accounts
- follow easyMarkets and xBar Cup Social Media accounts
- encourage audience voting
- create polls or quizzes to keep the audience engaged.
- (iii) Upload all their videos/ posts/ stories to easyMarkets social media channels for the purposes of the promotion. All content must be approved by easyMarkets before uploading.

4.2.1.1. xBar Cup 2025 competition – Freestylers:

- The xBar Cup 2025 competition for the (4) four Freestylers Winners will run in three rounds
- Each Freestyler will take (4) four shots as indicated in every round.
- Each of the 4 shots will be the same for every player but will be specified by the judges of the competition and will vary every round.
- Each shot has varied difficulty and varied point value:

Goal=1 point

Top Corner Buckets=2 points Sidebar=3 points



Crossbar=4 points

- The Contestant with the least points per round will be disqualified from the next round
- In case of a draw between the bottom two Contestants in the first and second round, a lighting round will apply
- In case of a draw between the top two Contestants in the final round, a lighting round will apply
- Lighting round: Contestants that are in a draw will take one shot from a position that will be specified during the competition by the judges. The Contestant whose ball is closest to the goal line, measured from the edge of the ball, will win and the contestant with the furthest distance will lose
- The order of the Contestants taking the shot will be decided after a lucky draw out of a hat
- 4.2.2. **Members of the audience (voters) tier:** (2) Two lucky Winners from members of the audience selected by a lucky draw.

 Contestant whose ball is closest to the goal line, measured from the edge

- The order of the Freestylers taking the shot will be decided after a lucky draw out of a hat
